



SUMMER PROMO'26

1. Validity period

The promotion is available for full-year or academic-year bookings for the 26/27 academic year

2. Eligibility

The promotion applies exclusively to Full-Year and Academic-Year bookings for the 2026/27 academic year made on or after June 30, 2026 at the following buildings:
